## INTRODUCTORY NOTES

The 2026 edition of *International Cataloguing Standards* contains information important to Thoroughbred breeders, sellers and buyers, including a full listing of stakes races of 2026 which will be accorded Group/Graded or Listed status in sales catalogues published by the world's major international auction houses under the auspices of SITA. Not listed herein are U. S. and Canadian stakes races of 2026 which will receive black type in such catalogues but are considered to be below Graded or Listed standards. An explanation of these races appears hereinafter under "Part I".

*International Cataloguing Standards* is organized in five parts, beginning with the introductory material. Users of this publication should bear in mind:

1. **RACES INCLUDED IN THIS EDITION AND THEIR RATINGS ARE FOR 2026 ONLY.** Races previously rated which are no longer rated or will not be renewed in 2026 do not appear. A race run under a new name will be followed by the old race name in parenthesis and italics, if the country provided the information. Previously rated races which have been upgraded or downgraded appear with their 2026 rating only.
2. **TO DETERMINE WHETHER A PARTICULAR HORSE IS A GROUP/GRADED OR LISTED WINNER YOU MUST REFER TO THE EDITION OF *International Cataloguing Standards* FOR THE YEAR IN WHICH THE HORSE WON THE RACE TO LEARN THE RATING OF THE RACE IN THAT YEAR.**
3. **NOT ALL RACES APPEARING IN THIS PUBLICATION ARE ACCORDED GROUP/GRADED, LISTED OR BLACK TYPE STATUS IN SALES CATALOGUES.** Certain data contained herein is for additional information only. The explanations set forth in the following paragraphs should be carefully reviewed before using this publication.

## PART I

Part I, on white paper, lists by country all stakes races of 2026 given Group/Graded or Listed status by the International Grading and Race Planning Advisory Committee (IRPAC) and approved by SITA. The first three finishers in all Group/Graded and Listed races appearing in Part I receive black type. Winners receive upper case black type; second and third place finishers receive lower case black type.

Group designators (-G1, -G2, -G3) were inaugurated in 1971 and became applicable to English, French, German, Irish and Italian races, but not applied to North American catalogue pages until 1973. Grade designators were similarly inaugurated in 1973 in the United States and Canada. No procedure existed to confer Group or Graded status on any race prior to those years. Beginning January 1, 1985, brackets [ ] replaced the dash preceding the designators. At this time, the designators could also be listed after a horse's name, indicating its best finish, if there was no room on a catalogue page to list a complete race name. As previously

stated, the first three finishers in a race will receive black type status, but beginning with races run in January 1, 1985, fourth place finishers in graded races run in countries listed in Part I of the "International Cataloguing Standards" will be recognized as official placings and those horses will also earn black type. This ruling was amended starting January 1, 1989, to award fourth place finishers black type status in Group or Grade 1 races only. A subsequent ruling beginning January 1, 1990, no longer awards black type status to fourth place finishers. At the discretion of the individual sales companies, fourth place finishes in Group/Graded or Listed races may be included on sales catalog pages, but may not convey black type.

Authorities accepted for determination of Group/Graded and Listed races in Part I are the European Pattern Committee for Britain, France, Germany, Ireland and other European countries; the TOBA American Graded Stakes Committee for the United States; and The Jockey Club of Canada for Canada. The Asian Pattern Committee for Australia, Hong Kong, Japan, New Zealand, South Africa, United Arab Emirates and other Asian countries. The OSAF has reviewed the lists for Argentina, Brazil, Chile, Peru, Uruguay and Venezuela.

## **PART II**

Part II, on blue paper, includes all Group/Graded and Listed races of countries which have not been accepted into Part I by IRPAC. The first three finishers in races listed in this Part receive black type as they meet IRPAC statistical standards, but have not for renewals since December 31, 1987 carried Group/Grade designators in catalogues published by SITA sales organizations, information regarding which may be found herein on page xvi. Groups/Grades listed in this Part are recognised only in the particular country. All races receive black type the equivalent of a Listed Race.

## **PART III**

Part III, on gray paper, includes all Group/Graded and Listed races of the countries which have not been accepted into Part II by IRPAC. Races listed in this Part do not receive black type under IRPAC standards for any renewals since December 31, 1988, *and are not carried or recognized in catalogues published by SITA sales organizations*. Race names and Groups/Grades listed in this Part are recognized only in the particular country.

## **PART IV**

Part IV, on yellow paper, is the Jump Race Supplement, which lists steeplechase and hurdle races contested in countries comprising Parts I, II and III of this publication. These races are listed in italic form in sales catalogues and regional preferences determine if the italic form is black type.

# IRPAC GUIDELINES

When considering applications for inclusion in the ICS Book and proposed changes from one part of the ICS Book to another (i.e. promotions and demotions), IRPAC will have regard to the following guiding principles:

## Eligibility

- a. Applications for inclusion will be considered from Racing Authorities (through the relevant Regional Committee) which are members of the IFHA or any of its Regional Federations and where the relevant Regional Federation and/or Regional Committee (as applicable) has endorsed such application.
- b. Races must be restricted to horses as defined in Article 12 or 13 of the IFHA International Agreement on Breeding, Racing and Wagering.

## Part I

- a. Countries must have a Committee or Industry Group to provide oversight of, and maintain, the Group/Graded races in its country.
- b. No Group/Graded races should have any geographically-based conditions of entry in regard to the place of the horse's birth, training or ownership (i.e. they must be open to international competition).
- c. The country must adopt and implement a specific process based on ratings or other measures of quality to assess the quality of its races, as per the requirements of the relevant Regional Committee.
- d. As Part I countries are intended to comprise the world's major racing countries, granting Group/Graded race status or upgrading a race to a higher Group/Grade must be justified by the quality of the runners, as per the requirements of the relevant Regional Committee (as notified to IRPAC). Quality can be assessed by different systems including ratings, past performances and points.
- e. Except in exceptional circumstances, each country in Part I must have a minimum of (i) two Group 1/Grade 1 races, or (ii) a total of ten Group/Grade races (including at least one Group 1/Grade 1 race).
- f. Listed race status must be justified by the quality of the runners as per the requirements of the relevant Regional Committee (as notified to IRPAC). Quality can be assessed by different systems including ratings, past performances and points.
- g. Except in exceptional circumstances, Group/Graded races should be downgraded or lose their status if the quality of the runners does not justify the Group/Grade.
- h. Listed races should be downgraded if the quality of runners does not justify Listed status or if they do not adhere to published national standards that ensure quality runners.

- i. To upgrade an existing Group/Graded race, the race must have been run a minimum of two years around the same date, with similar race conditions and comparable prize money, and satisfy the relevant quality criteria.
- j. New Group 1 or 2/Grade 1 or 2 races may only be created without prior running under the following exceptional circumstances:
  - i. this creation must be induced by the implementation of a project or event of regional or global importance. Such project or event should be designed to have a major impact on the racing and/or breeding activity of all countries in the relevant region and eventually for such activity worldwide;
  - ii. the project or event must be unanimously supported by the members of each relevant Regional Committee responsible for controlling quality in the existing Group/Graded system;
  - iii. the project or event must have been notified by the Regional Committee to IRPAC, with sufficient detail and justification for exceptional circumstances no later than 30 days prior to the next scheduled IRPAC meeting; and
  - iv. any race granted Group/Graded status under exceptional circumstances must be reviewed every year by the relevant Regional Committee responsible for controlling quality in the existing Group/Graded system, and should be automatically downgraded after three runnings if the quality of the runners does not comply with the stated criteria.

### Promotions to Part I

- a. Racing in these countries must be of sufficient stature in terms of number of horses competing, number of races contested and prize money distributed to justify their classification as being among the world's major racing countries.
- b. The number and percentage of races given Group/Graded or black type status in these countries should be consistent with the pattern of racing in the country without being disproportionate to the ratio of such races in the countries already in Part I.
- c. The Group/Grade and Listed races in these countries are the highest class races contested within them.
- d. Except in exceptional circumstances, in order to be eligible for promotion to Part I each country must have a minimum of (i) two Group 1/Grade 1 races or (ii) a total of ten Group/Grade races (including at least one Group 1/Grade 1 race).
- e. Ratings and other measures of quality shall have been reviewed by the relevant Regional Committee and be acceptable for Part I.

- f. Individual races of a Part II of Part III country can be promoted to Part I after two runnings if their quality complies with international Group/ Graded status.

## **Part II**

- a. The country must adopt and implement a specific process based on ratings or other measures of quality to assess the quality of its races.
- b. Races included in Part II are provided with Listed status and should be justified by the quality of the runners and any other factors considered relevant by the relevant Regional Committee (as notified to IRPAC). The percentage of black-type races to the total number of races run in that country will be taken into consideration, with a preference that it should be no higher than 3%.
- c. The ratio of the number of different horses to start in that country to the number of black type races will be taken into consideration, with a preference that it should be no lower than 40:1.
- d. The percentage of black type races which are open to foreign horses will be considered.
- e. The performances of the horses trained in that country when racing abroad, together with those of foreign-trained horses when racing in that country, will be considered.
- f. Individual races of a Part III country can be promoted to Part II after two runnings if their quality complies with the relevant criteria for Listed status.

## **Part III**

- a. IRPAC will consider various information in respect of the relevant applicant country, including:
  - i. the number of horses in training
  - ii. the number of races;
  - iii. details of imported horses;
  - iv. prize money structure and any bonus schemes;
  - v. a summary of their breeding industry (if any), including the number of stallions, mares and foals; and
  - vi. an overview of the Racing Authority that regulates racing in that jurisdiction.

- ♦ European and Mediterranean Horseracing Federation(EMHF) / European Pattern Committee (EPC)
- ♦ Asian Racing Federation (ARF) / Asian Pattern Committee (APC)
- ♦ American Graded Stakes Committee (AGSC) and Canadian Graded Stakes Committee (CGSC)
- ♦ Organizacion LatinoAmericana de Fomenta del Pura Sangre de Carrera (OSAF).

Races in each Part are set forth alphabetically by country with the name of the sponsor being indicated between brackets after the name of the race. Indices are included at the ends of Parts I, II and III.

## **INTERNATIONAL GRADING AND RACE PLANNING ADVISORY COMMITTEE (IRPAC)**

### **Introduction**

The International Cataloguing Standards Committee (ICSC) was founded in 1981 to achieve uniformity of global cataloguing standards. It was initially made up of representatives of the racing authorities, breeders' organisations, and international auction houses of England, France, Ireland and the USA. Organizacion Sudamericana de Fomento del Sangre Pura De Carrera (OSAF) was added in 1995 and the Asian Racing Federation (ARF) was added in 1996.

In 1983, The Society of International Thoroughbred Auctioneers (SITA) was created, largely as a forum for the discussion of subjects of mutual interest to international thoroughbred auctioneers. The International Cataloguing Standards and International Statistics Book (ICS Book) contains a full listing of stakes races for the relevant year which will be accorded Group/Graded or Listed status in sales catalogues published by the sales companies that form SITA.

In 2002, the International Federation of Horseracing Authorities (IFHA) established the International Grading & Race Planning Advisory Committee (IRPAC) and, in 2007, the ICSC transferred to IRPAC the responsibilities for making decisions in relation to promotions and demotions to the different parts of the ICS Book.

### **Purpose**

1. IRPAC is a committee of the IFHA Executive Council.
2. The primary objectives of IRPAC are to:
  - a. provide guidance to regional pattern/graded stakes committees (Regional Committees) in respect of black type quality control matters;
  - b. make decisions in relation to applications for inclusion in the ICS Book and proposed changes from one part of the ICS Book to another;
  - c. coordinate the annual publication of the ICS Book; and
  - d. facilitate communication between stakeholders in relation to black type quality control matters.

## **INTERNATIONAL GRADING AND RACE PLANNING ADVISORY COMMITTEE (IRPAC)**

### **Functions**

1. The general roles and responsibilities of IRPAC are to:
  - a. provide guidance to Regional Committees in respect of black type quality control matters, including in relation to:
    - i. improving quality control systems;
    - ii. ensuring there is a common understanding and a level of general agreement in respect of quality control principles and frameworks;
    - iii. the international racing calendar and new international races; and
    - iv. the implementation of a pattern/grading system in any country;
  - b. facilitate communication between stakeholders, including Regional Committees, Regional Federations, Racing Authorities and SITA, in relation to black type quality control matters; and
  - c. provide advice and regular reports to the IFHA Executive Council in relation to black type quality control matters.
2. The roles and responsibilities of IRPAC in relation to the ICS Book are to:
  - a. in respect of proposed changes within the same part of the ICS Book:
    - i. consider decisions made by Regional Committees (for noting);
    - ii. provide reports of significant decisions made by Regional Committees to SITA (for noting by SITA); and
    - iii. in exceptional cases, recommend to Regional Committees that decisions made by them are reconsidered;
  - b. in respect of applications for inclusion in the ICS Book and proposed changes from one part of the ICS Book to another (i.e. promotions and demotions):
    - i. consider recommendations made by Regional Committees (for decision/endorsement); and
    - ii. where endorsement is given, provide recommendations to SITA (for ratification by SITA); and
  - c. coordinate the annual publication of the ICS Book.

3. For the sake of clarity, in fulfilling its functions it is not the role of IRPAC to impose conditions which seek to achieve global uniformity with respect to black type quality control.
4. The roles and responsibilities of IRPAC in relation to the WBRRC are to:
  - a. consider for endorsement any amendments to the WBRRC terms of reference (to be approved by the IFHA Executive Council);
  - b. consider for endorsement any policies and procedures formulated by the WBRRC (to be approved by the IFHA Executive Council);  
and
  - c. receive from the WBRRC notification of any significant reports (including those containing the end of year rankings), decisions or policies/ procedures agreed.

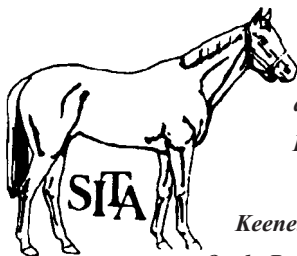

## **BLACK TYPE DESIGNATORS FOR NORTH AMERICAN RACING**

**In 2026, for a stakes race in the United States or Canada to receive black type in SITA catalogues, it must:**

- **Have a minimum purse value of \$50,000 available for distribution on the day of the race.**
- **Close at least 72 hours in advance of its running, have a fee paid for entrant, and have a total purse value distributed on the day of the race equal to or greater than the established minimum.**
- **All entries must be eligible for the purse monies used to determine the minimum purse value for black type.**
- **Have no restrictions other than state-bred, non-winners of a sweepstakes, sales graduates or state or province based stallions' progeny.**
- **May not contain a preference clause(s) based on criteria unrelated to the quality of the horse if such preference clause(s) could possibly exclude any horse(s) of superior quality from competing.**
- **Must have a black type Race Quality Score (RQS) equal to or above the established minimum Race Quality Score for its age/sex division. New races with a minimum purse of \$75,000 available to all entries may be submitted to North American ICSC for review to determine if the inaugural running will receive black type status. ### ***DESIGNATOR DEFINITION***

**G1, G2, G3** A non-restricted race with added money or guaranteed purse value of \$100,000 or more which has been run at least twice under similar conditions and on the same surface and has been assigned graded stakes status for the year contested by the American Graded Stakes Committee of the Thoroughbred Owners and Breeders Association (TOBA) for the United States, or The Jockey Club of Canada Graded Stakes Committee for Canada. The American Graded Stakes Committee has set the following minimum purse requirements for each grade level: G1 - \$300,000, G2 - \$200,000, and G3 - \$100,000. The Jockey Club of Canada's Graded Stakes Committee minimums are: G1 - \$250,000, G2 - \$150,000, and G3 - \$100,000.

**L LISTED RACE** Listed races in North America for 2026 have a value of \$75,000 or more available to all starters and have been assigned Listed status by the American Graded Stakes Committee of the Thoroughbred Owners and Breeders Association (TOBA) for the United States, or The Jockey Club of Canada Graded Stakes Committee for Canada. Prior to 1985 Listed races receive the designator –L (or -LR if restricted.) In 1985 the designators were changed to [L] or [LR]. Beginning in 1986 the track abbreviation where the race was run and the amount of money earned by the individual is carried in parentheses following the designators. Beginning in 1991 and until 2018 a Listed race may not be restricted. Starting in 2018 a Listed race may be Restricted to non-winners of a Sweepstakes which will be displayed as [LR].

**R RESTRICTED RACE** A race restricted to certain runners as defined by the conditions of the race. These conditions tend to exclude runners of greater quality for considerations other than sex or age. These races receive the designator -R.

**FOR 1985 RACING ONLY**

**O OTHER ADDED MONEY BLACK TYPE RACES** [O] (or [OR] if restricted) designator for 1985 only.

**Q QUALIFIED RACE** [Q] races are unrestricted allowance and handicap races with a purse value of \$30,000 or more. These races received black type status in 1985 only.

**N NON-QUALIFIED** These races are stakes races that were run in 1985 only and had an added money value of less than \$15,000. They do not receive black type but are identified by the [N] designator.

**HURDLE OR JUMP RACES** Hurdle and jump races were included in Parts I, II and III of the “*International Cataloguing Standards*” book and qualified for black type status dependent upon their placement until January 1, 1986. Beginning with this date, these races were placed in Part IV of the publication and lost their black type status for catalogues produced using North American ICSC guidelines. Horses which won or placed in a hurdle or jump race since January 1, 1986 are now identified by their names carried in *italic mixed case*.

The grading of races began in 1973 as a TOBA project primarily at the request of European authorities anxious that North America have a system similar to their Group race structure.

In most European countries all races are planned, even dictated by a central authority. Thus, from year to year, most races will be run at approximately the same time, under the same conditions and in the same relationship with each other. In the United States no such constancy can exist; no central authority prescribes a comprehensive racing calendar; individual racetracks annually plan their own stakes schedules. As a result, any grading system must be flexible and allow for prompt responses to change.

The Committee is composed of members of the Thoroughbred industry who meet annually to issue their collective opinion concerning the relative quality of certain Thoroughbred races in the United States. The Committee ranks eligible races as Grade 1, Grade 2, Grade 3 and Listed, with Grade 1 being the highest.

**CRITERIA FOR CONSIDERATION FOR GRADING**

The Committee has adopted the following criteria for screening U.S. races:

*Purse requirement* - a minimum of \$75,000 in added or guaranteed money, excluding state-bred supplements.

*Longevity* - two previous runnings under fundamentally the same conditions.

*Drug testing* - Post-race drug testing performed on samples from horses participating in graded stakes must meet or exceed the guidelines in the committee's drug testing protocol. Jurisdictions or racetracks participating in good standing in the Horseracing Integrity and Safety Authority's anti-doping and medication control program are considered to meet this requirement.

*Medication* - Races are ineligible for grading if Association of Racing Commissioners International model rules on androgenic-anabolic steroids and non-steroidal anti-inflammatory drugs are not adopted. Jurisdictions or racetracks participating in good standing in the Horseracing Integrity and Safety Authority's anti-doping and medication control program are considered to meet this requirement.

*Restricted races* - Races will be ineligible for grading if conditions for competing in them include restrictive provisions relative to which horses may enter, other than by sex and age. A race is regarded as a restricted race if any of its conditions for entry would tend to exclude better horses while allowing participation by lesser horses. Beginning in 2018, races restricted to non-winners of a sweepstakes and meeting all other eligibility requirements are eligible for Listed status.

*Preference conditions* - Preference conditions should be written to industry acceptable standards, i.e., high weights, graded wins/placings, graded earnings, points from graded wins/placings, etc., with the goal of achieving the highest quality field. Deviating from standard preference practices may result in fields of lesser quality, which could lead to downgrading through the graded stakes review process.

*Invitational races* - Invitational races are eligible for grading if the added or guaranteed money is a minimum of \$75,000 and the race meets the other criteria.

*Changes in conditions by race* - If a race is altered materially in age, sex, eligibility, race track location, purse, distance or substantially changed on the calendar (30 days or more), this will prompt a review and may result in a change in grade.

*Forced changes in track surface and splitting of races* - A graded race scheduled for the turf, but moved to the dirt because the turf course is unsuitable for racing, may be downgraded one grade level for that running only. A graded race is not penalized if it is split into divisions unless the total purse for all divisions is less than 150% of the original purse.

Committee members bring judgment and knowledge to every grading decision. The grades, therefore, are a composite of expert opinion, rather than the result solely of statistical analysis.

The TOBA/American Graded Stakes Committee is composed of six TOBA members, appointed by TOBA's Chairman and confirmed by its trustees, with rotating three-year terms, three of which may be consecutive; and five racing official members, elected by the six TOBA members, with three-year terms, three of which may be consecutive. The terms for each member commence on August 1. Any racing official on the Committee whose employment status changes significantly during his or her term on the Committee automatically vacates his or her position on the Committee.

### **Interpretation of Races Run Abroad, For the Purpose of Qualification for Races and/or the Assignment of Weights**

Racing Authorities should publish, and make available to other Racing Authorities on request, details of the way in which races run in other countries would be treated. For the purpose of determining penalties, allowances and qualifications in connection with the winning of any Flat Races:

- Races appearing in Part I of the International Cataloguing Standards Book shall be regarded as being of the status (Group/Graded or Listed) as described.
- Races appearing in Part II of the International Cataloguing Standards Book shall be regarded as being of Listed status.
- Races appearing in neither Part I nor Part II of the International Cataloguing Standards Book shall be regarded as being of neither Group nor Listed status.

This approach is particularly pertinent to countries (or for races) featuring in Part I.

## LIST OF ABBREVIATIONS

“a” preceding a distance indicates that the distance is approximate rather than exact.

“(E.B.F.)” following a race name indicates the purse of the race has been supplemented by the European Breeders Fund.

“(H)” following a race name indicates that the race is a handicap race.

“N/A” located in any field indicates the data for that field was not available at the time of publication or that the information is not applicable.

“(R)” or “(LR)” following a race name indicates that the race is restricted to certain runners which are further defined in the conditions of the race.

“D” following a distance indicates the race is scheduled to be run on a dirt course.

“T” following a distance indicates the race is scheduled to be run on a turf course.

“awt” following a distance indicates the race is scheduled to be run on an all weather track.

Races with sex restrictions will be designated with the following abbreviations following the age:

c = colts

g = geldings

f = fillies

m = mares

## EXPLANATORY NOTES

### Distance Conversion

Race distances are computed differently in individual countries. Furlongs, miles and meters are all commonly used to describe the distance of a race. A meter is equal to 39.37 inches; a 1600 meter race is about 30 feet short of a mile. For the purpose of this book, the following equivalents are used:

One Mile = 1600 meters

8 furlongs = One Mile
